



BREEDING CONTRACT

I, _____, hereby agree to breed the Mare _____
Registration # _____, to the Stallion: Munez Smokin Tater, AQHA # 4972965
His Sire: Smokin Streak, AQHA Registration # 4509872, and His Dam: Munez Tater Sue, AQHA Registration # 2903847

The fee for such service shall be \$500.00 which includes a \$50.00 booking fee that also serves as a non-refundable deposit, payable before the arrival of the Mare along with this signed contract and a copy of said mares registration papers (if applicable) leaving a balance of \$450.00 payable upon (or before) arrival of Mare to The Lewis Ranch Stallion Station or before semen will be shipped in the case of cooled shipped semen. (This stud fee is waived if this is a breedback on the live foal guarantee with the exception of a \$50 re-booking fee). Return privileges for rebreed are through July 1st of the year following the original breeding contract date.

Stallion owner offers, for this stallion only, a free breeding back to this stallion or a "stud fee refund" (mare care, chute/shipping expenses and \$50 booking fee excluded) if mare owner shows a resulting foal by this stallion and produces proof that said foal has earned points with AQHA or APHA and/or money through NRHA, NCHA or NRCHA. Stallion owner offers this as a "no risk" option for a mare owner who wants to show the resulting foal in the future, to breed said stallion again with no additional stud fee, or claim a "refund" of the stud fee already paid, resulting in the winning foal. Stallion owner requires that the original mare owner be the owner listed on the foal's registration papers at the time the refund/free breeding is claimed and at the time that the foal won money and/or obtained points.

The Lewis Ranch Stallion Station/Stallion Owner offers early bird discounts of \$50 for mares booked before January 1 each year and also offers multiple mare discounts when booking more than one mare (this includes booking with a friend or referring a friend and is not limited to booking to the same stallion). Is this a Breedback? Yes _____ No _____ Re-booking fee for a breedback is \$50 and must be paid upon the arrival of the mare. Board for the Mare shall be at the rate of \$7.00 per day for Dry Mare care and \$9.00 per day for Wet Mare care (with foal at side). This fee is payable upon the Mares departure along with any balance of the Stud fee and any Veterinarian/farrier fees due. All Mare care and expenses on mare/foal shall be paid upon mare's departure/ monthly upon receipt of invoice via email or USPS at the end of each month. The Lewis Ranch Stallion Station strongly suggests Mare be checked by a Veterinarian for breeding condition and cultured (exceptions: Maiden mares) to insure she is free from infectious, contagious or transmittable disease and clean for breeding and will attempt to settle mare with reasonable diligence and may, at their discretion check said mare for follicular activity in the event she is not showing estrus after 15 days of teasing protocol. If, however, for any reason the mare does not settle, mare owner will hold The Lewis Ranch Stallion Station/Stallion Owner harmless as they shall assume no liability for a Mare that will not breed, cannot conceive, or for accident, sickness or death of the Mare or foal, but will exercise every reasonable effort to settle Mare and use good judgment in care and supervision of Mare and her foal. Mare owner, in turn, shall not be responsible for injury or accident to Stallion caused during breeding of the Mare. There will be no refund on breeding or booking fees and the breeding season for this Stallion begins February 1 and ends July 1. If Mare fails to conceive, The Lewis Ranch Stallion Station/Stallion owner will provide breeding the following year, free of charge (with the exception of a re-booking fee of \$50 and mare care/shipping expenses). The Lewis Ranch Stallion Station/Stallion owner guarantees a live foal. It is hereby agreed that a live foal is a foal that stands and nurses without assistance. **Please Note that The Lewis Ranch Stallion Station/Stallion owner strongly suggest that the mare remain at the Stallion Station for 17 days following her last breeding so she can be re-bred immediately if signs of estrus appear/ sent home if no signs are apparent and pregnancy can be assumed. An ultrasound is also strongly suggested, to ensure pregnancy before the mare leaves the ranch therefore alleviating any doubt and lessen the possibility of a barren mare. The Lewis Ranch Stallion Station/Stallion owner will not be responsible for mares that do not settle if mare owner will not leave the mare with Stallion Station to be bred for more than one cycle, if it becomes necessary.

This contract shall not be transferable by Mare Owner without prior consent of The Lewis Ranch Stallion Station/Stallion Owner. A Breeder's Certificate for registering the foal will only be issued after notification of the birth of the live foal and after all bills on the Mare have been paid.

I, Tina Lewis, Stallion Station owner, do not make any other warranties or guarantees, implied or expressed in reference to the above contract.
